**ANTHONY DEStEFANIS**, *Assistant Professor, Department of History and Political Science*  
“Guarding the Empire: Soldier Strikebreakers on the Long Road to the Ludlow Massacre”

**AMY JOHNSON**, *Associate Professor, Department of Art*  
“Crooked and Narrow Streets: Photography and Urban Visual Identities in the Early Twentieth Century”  
This project requests funding for image reproductions required for publication of Amy’s article, “Crooked and Narrow Streets: Photography and Urban Visual Identities in the Early Twentieth Century.” In this article, she examines the role of photography in shaping multiple conceptions of urban identity in the early twentieth century, particularly regarding the transition from the urban reformer’s documentary photographs to the preservationist’s celebration of the crooked and narrow streets as relics of the city’s heroic past, as seen in Annie Haven Thwing’s book, *The Crooked and Narrow Streets of the Town of Boston*. Images are central to the methods and argumentation of the project and are required for publication. The article has been accepted for publication in *Winterthur Portfolio* in Spring 2013.

**JONATHAN JOHNSON**, *Assistant Professor, Department of Art*  
“Invisible Being: A Digital Humanities Project”  
Invisible Being is a digital humanities project that will create an innovative and interactive online experience to document, through image, video and text (with academic essays and critical writing from student researchers), the creative projects that Thai artists have undertaken in response to major environmental and political events that have occurred between the 2004 Asian tsunami and the current political tension between rural and urban populations. Invisible Being will: serve as an open repository for content created and collected by Jonathan and students in his Contemporary Thai Cinemas course; act as a resource for students and academics by providing a useable prototype of an innovate classroom experience; and encourage dialogue about the interdisciplinary potential of the humanities and creative work at Otterbein University and beyond.

**KAREN STEIGMAN**, *Assistant Professor, Department of English*  
“Graham Greene and the Politics of Involvement”  
Karen is currently researching an essay on the theme of political involvement as it appears in three Greene novels of the latter decades spanning his long career: *Our Man in Havana* (1958), *The Comedians* (1966), and *The Human Factor* (1978). She will do archival research at the Graham Greene Library and Archive, Burns Library, Boston College, for one week in June 2012. The Burns Library is one of three major archival repositories of Greene's work. She will look specifically at the library's extensive holdings of Greene's unpublished political and non-fiction writings on Latin America in the 50s and 60s (journals, diaries, personal correspondence) to track his development of the concept of involvement in the novels. She will complete an essay draft by December 31, 2012

and present her research at a special session on Greene at MLA (January 3-6, 2013; pending acceptance).

**RICHARD YNTEMA**, *Associate Professor, Department of History and Political Science*

**“Guilds as Rent-Seeking Organizations? A Case Study of the Divergent Interests of Brewers' Guilds in Early Modern Holland”**

This research project proposes to contribute to debates about if guilds were rent-seeking institutions, namely, institutions that benefited guildsmen and harmed consumers and society more generally. Most scholars, including Sheilagh Ogilvie, argue that guilds were rent-seeking institutions and impeded European economic development. Epstein and Prak, in contrast, have argued that guilds promoted economic development and technological change. The archival project Richard is undertaking seeks to show that the economic impact of guilds depended on the industry's geographic location and underlying comparative advantage. This case study of brewing guilds in Holland argues that rent seeking occurred when a town's brewers' guild was at a comparative disadvantage with rivals, but not in export-oriented towns with a comparative advantage. In other words, guilds policies could either promote trade and growth or restrict economic growth through rent-seeking practices and policies. The path guilds followed depended on their relative comparative advantage in the regional economy.

This proposal is for the HAC Summer Writing Award. Daniel is currently working on an essay that offers a new interpretation of Sigmund Freud's *Moses and Monotheism*. Traditionally, this book is read as a controversial statement on Jewish identity. Deviating from this tradition, he argues that the book is an account of the origins of modern European society. Along with a close reading of *Moses and Monotheism*, he connects this concern for the origins of modernity with contemporary debates on the same topic with the intention of demonstrating the singularity of the psychoanalytic interpretation.

**BETH RIGEL DAUGHERTY**, *Professor, Department of English*

**“Completing Chapter Four and Polishing Chapter Two in Virginia Woolf's *Apprenticeship* Manuscript”**

Between May 28 and August 19, 2012, Beth will 1) draft the four major undrafted portions of Chapter Four in her manuscript entitled *Virginia Woolf's Apprenticeship: The Education of a Woman Writer*; 2) revise the entire chapter; and 3) polish Chapter Two.

**MARCUS E. GREEN**, *Assistant Professor, Department of History and Political Science*

**“Gramsci on ‘the Simple,’ Religion, and Subalternity”**

Marcus' proposal for the HAC Summer 2012 Writing Award involves the writing and completion of a journal-length manuscript, tentatively entitled “Gramsci on ‘the Simple,’ Religion, and Subalternity,” which he intends to submit to the peer-reviewed academic journal *Culture and Religion*.

“Miscellany of Form in John Gay's Trivia”

Margaret is applying for an HAC Summer Writing Award to support her project to expand and revise a short section of her dissertation into an article. Her goal is to produce an article tentatively titled, "Miscellany of Form in John Gay's Trivia." This article would begin from a brief reading of Gay's poem in her dissertation, and would expand it particularly in light of insights she gained from completing her book project "Poetry of Attention in the 18<sup>th</sup> Century." By the end of summer 2012, her goal is to send this article to a new journal called Eighteenth-Century Poetry.

**SHANNON LAKANEN**, *Associate Professor, Department of English*

“In Defense of Whimsy: A Collection of A.A. Milne’s Personal Essays”

Shannon will complete the critical introduction and collect the contents of a collection of A.A. Milne’s personal essays; additionally, she will complete at least four book proposals for submitting the manuscript for publication...and will have mail one of these proposals before the end of the grant period.

**STEPHANIE PATRIDGE**, *Associate Professor, Department of Religion and Philosophy*

“Moral and Aesthetic Contextualism”

Berys Gaut reconceptualizes the main positions in the art and ethics debate as autonomism, contextualism, and ethicism. Explicit talk of contextualism into the art and ethics debate is welcome. However, the belief is that the way that Gaut conceives of contextualism obscures some features that are relevant for determining if a view is genuinely contextualist or not. There will be argument that Gautian ethicism is either prima facie implausible, or that it is formally identical to the contextualist alternative that he sets himself up against. In the latter case, there will be argument that Gaut’s arguments in favor of ethicism are rendered inert.

**KAREN STEIGMAN**, *Assistant Professor, Department of English*

“Graham Greene and the Politics of Involvement”

Karen is applying for the 2012 Humanities Summer Award to support the writing of her essay entitled “Graham Greene and & the Politics of Involvement”.

The Ohio Humanities Council, a state affiliate of the National Endowment of the Humanities (\$15,000) and The Martha Holden Jennings Foundation (\$5,000). “The Language of Nature: Reading the Earth” is a week-long institute for approximately 20 classroom school teachers held at the Cuyahoga Valley Environmental Education Center. It brings together three strands of interest and concern in the contemporary humanities: 1) the need to help teachers better connect their students to the world beyond the classroom; 2) the imperative to make best use of contemporary insights “how we think,” and finally 3) our pressing need as a nation and a culture to re-establish stronger bonds with the natural world.

**NICHOLAS HILL**, *Professor, Department of Art*

Ohio Arts Council (\$12,608). “Time and Place: An International Exhibition of Works on Paper” is an invitational exhibition of works by Ohio and German artists who have participated in the Ohio Arts Council's printmaking exchange program. As curator, Nicholas has been invited to organize the exhibition to be presented at the Standehaus gallery in Dresden during summer 2012. This exhibition will bring attention to current work by contemporary German and Ohio artists in a prestigious exhibition venue in Germany. The exhibition will also be shown in The Ohio State University's Urban Arts Space in Fall 2012.

**PATRICIA KEANE**, *Professor, Department of Nursing*

Health Resources and Services Administration of the Department of Health and Human Services (\$27,098). This is a continuation of the Advanced Education Nursing Traineeship scholarship program.

**JOHN KENGLA**, *Senior Instructor*

The Columbus Foundation (\$32,000) and Columbus City Schools (\$8,000). The two awards will fund the UBUNTU program. Through group mentoring, urban high school and Otterbein University students increase their engagement in learning, self-awareness, character development, and civic responsibility; the high school students gain access to and a vision to pursue higher education.

Columbus Foundation (\$1,500). This funding supported the Girls Going Places<sup>®</sup> Entrepreneurship Conference held in May 2011. Otterbein’s partnership with the Columbus City Schools, the National Association of Women Business Owners, and the Columbus Financial Group, Inc. made this event possible for 100 middle school girls.

**BARBARA SCHAFFNER**, *Professor, Department of Nursing*

Ohio Board of Nursing (\$199,685). The purpose of this project, “Nursing, Academic and Community Partnerships (NCAP)”, is to increase the enrollment of pre-licensure nursing students by 10%; develop additional non-traditional community partnerships to allow increased access to healthcare training sites; revise the curriculum to include additional emphasis on targeted areas such as quality improvement, safety, culture, gerontology and informatics; and to provide lifelong learning for the post-licensure nurses of the community partners through continuing education offerings and simulations.

**ELIZABETH SEIBERT**, *Professor and Director, CRNA Program, Department of Nursing*

Health Resources and Services Administration of the Department of Health and Human Services (\$1,292). This grant offers scholarships to increase the number of advanced practice nurses who provide health services to diverse underserved populations in rural counties in Central and Appalachian Ohio.

**WENDY SHERMAN-HECKLER**, *Associate Professor, Department of Education*

Ohio Board of Regents (\$106,480). Funding will support a 3<sup>rd</sup> year of “OP2 – Operation Physics for Central Ohio Middle Grade Teachers”. The goal of this project is to develop a better understanding of basic physics among central Ohio based teachers of students in grades 4-9. Teachers will enroll in 5 semester credit hours of graduate coursework through Otterbein University, with tuition paid for by the Ohio Board of Regents. The coursework will provide teachers with sequences of inquiry activities, demonstration, readings and outside projects to be completed with their students. Teachers will learn to recognize and challenge some naive ideas in order to inspire student interest in physics concepts, encourage problem solving, and improve student learning in areas of physical science specified in Ohio's Academic Standards. Teacher participants will receive approximately 100 hours of instruction during Summer and Fall 2012 and Spring 2013.

**MARJORIE VOGT**, *Professor, Department of Nursing*

Ohio Board of Nursing (\$199,671). The specific goals of this project, “Linking Education and Practice Partnerships Program (LEAPPP)” include increasing the numbers of master’s or doctoral post-licensure student nurses by 10% through development of partnerships with select educational programs and healthcare agencies; collaborate with community partners to increase the number of post-licensure nurses prepared in the role of Nurse Educator; and provide opportunities for nursing staff of community partners by using distance learning techniques to promote nursing staff life-long learning.
